

PARENT INFORMATION
Cub Resident and Webelos Extended Camp

- **LOCATION** – The Hawk Mountain Scout Reservation is located in Schuylkill County, Pennsylvania, just off Route 183. From the south, take Interstate 78 to Route 183 North. Cross over the Blue Mountain. At the base of the mountain, turn left just past the Blue Ridge Inn onto Blue Mountain Road, follow the signs into camp. From the north take Route 183 South. Make a right turn just before the Blue Ridge Inn onto Blue Mountain Road and follow the signs.

ALL VEHICLES MUST BE PARKED IN THE PARKING LOT.

- **FEES** – The fee for Hawk Mountain Council Cub Resident Camp is \$115.00 per Scout. The fee for Webelos Extended is \$140.00 per Scout. Leader fees are listed in the Cub Camping Guidebook.
- **MEDICAL FORM** – All Scouts and Leaders must have a physical form in order to take part in activities at camp. A physical is not required by your doctor.
- **HEALTH LODGE** – The camp operates a Health Lodge for the treatment of minor injuries. In the event of a serious injury, the parent would be contacted before the Scout would be transported to a local clinic or hospital. All accidents must be reported to the Health Officer to ensure insurance coverage. The Health Lodge phone number is: (570) 754-7892.
- **EMERGENCIES** – If an emergency arises and you need to contact your son, call the camp office (570) 754-7552. After hours (8:00 PM to 8:30 AM) call the Health Lodge at 570-754-7892.
- **INSURANCE** – The camp covers health and accident insurance coverage for all Scouts and Leaders who are registered. Itemized bills should be submitted to the Reservation Office.
- **VISITORS** – Visitors are welcome at Hawk Mountain Scout Reservation. **ALL VISITORS MUST CHECK-IN AT THE CUB ADMINISTRATION BUILDING FOR CUB RESIDENT AND THE BOY SCOUT ADMINISTRATION BUILDING FOR WEBELOS EXTENDED BEFORE GOING TO A CAMPSITE. No pets are allowed in camp at any time. We request that right to verify identification of any person that visits camp.**
- **LEAVING CAMP** – Before a Scout or Leader can leave camp, we ask that you sign-out at the Administration Building. This will enable us to know the whereabouts of all persons in camp in case of an emergency. If a Scout is signed out by someone other than the parent or legal guardian, we need permission and have the right to request identification of the adult.
- **REFUNDS** – No refunds will be given unless there is an illness or death in the immediate family. All refund requests must be in writing and made by August 20, 2010. Any refunds given will be subject to a \$5 processing fee. Campership monies will not be refunded nor transferred

- **MAIL SERVICE** – Mail deliveries and collections are made daily at the Administration Building at 11:00 AM. Incoming mail should have the following information:
